veterinary bills will be covered by Southern ROOTS Rescue, Inc. provided any vet service or medication was approved prior to			
treatment and a Southern ROOTS Rescue, Inc. veterinarian is used. In the case of a life or death situation, when every moment			
counts, the FOSTER HOME will not hesitate to take the dog(s) to a vet or emergency clinic if after regular vet hours, and will contact			
the Foster Home Coordinator as soon as practical thereafter.
